Course Description

In this course, we will cover classic operating system (OS) design principles, including structure, abstractions (processes, virtual memory), concurrency, I/O, as well as broader and more recent areas including distributed systems, security, and virtualization.

By the end of this course, you will have in-depth exposure to core operating system concepts as well as their historical roots and experimental innovations.

Policy Statements

Academic Integrity

Responses to Academic Dishonesty, Plagiarism, or Cheating
